2. **OBEY ALL LAWS FOR THE PROPER OPERATION OF A MOTOR VEHICLE, INCLUDING, BUT NOT LIMITED TO, NO DRINKING OF ALCOHOLIC BEVERAGES OR BEING UNDER THE INFLUENCE OF MIND ALTERING SUBSTANCES;**
3. **BE AT SPRING STREET AT 4:30 P.M. FRIDAY, JANUARY 7, 2022;**
4. ***NO KREWE MEMBERS ARE ALLOWED TO RIDE ON THE FLOAT DURING LINE UP PROCESSION OR DURING THE EXITING OF THE FLOATS AFTER THE EVENT;***
5. **BE RESPONSIBLE FOR ALL ACTIONS REGARDING YOUR KREWE AND YOUR FLOAT BEFORE, DURING AND AFTER THE EVENT.**

We understand and agree that if we do not comply with the rules of the event, and the instructions given to us by event marshals, officials, or the City of Pensacola Police Department, our participation in the line up will be terminated and we will not be permitted to continue in the event. Pensacola Mardi Gras, Inc. reserves the right to deny any application for participant. Once the Krewe participates the undersigned agrees to having full responsibility of their Krewe and the actions of their Krewe Members.

Furthermore, in exchange for the right to participate in the Event, the undersigned, a duly authorized representative of _____, an organization participating in the Event agrees to indemnify and hold harmless the City of Pensacola, Pensacola Mardi Gras, Inc. and related entities, all agents, employees and volunteers of said organizations from any liability, claim or expense of whatever kind or nature, whether caused by the negligence of the undersigned or otherwise, arising out of activities as an Event participant of the undersigned Organization and any of its representatives or individual participants. This indemnification and hold harmless agreement shall be governed in all respects under the laws of the State of Florida.
